# STATED MEETING #5 Online Via Zoom February 15, MMXXII MINUTES.

#### Call to Order.

In accordance with the bylaws and electronic meeting policy of the Presbytery of Northeast New Jersey, the 5<sup>th</sup> Stated Meeting of the Presbytery of Northeast New Jersey was called to order on Saturday, February 15, 2022, using ZOOM technology as a result of the continuing COVID-19 related restrictions on large in person gatherings. The docket for the meeting was arranged using a worshipful work format in which elements of worship and business are interspersed throughout the meeting. The meeting was called to order, folioing a slight technical delay at 7:18 pm (EST), by the Moderator Rev. Dr. Wanda Lundy (Siloam-Hope First) and opened with prayer.

#### **Board of Pensions.**

**Rev. Dr. Carrie Mitchell** presented the brief update of the Board of Pensions. She shared that assistance programs have been expanded to include more eligible people and to be available in more situations. She also shared that at present the Board provides benefits to more lay people than ministers, that a new "Care Navigator" program is being rolled out in the spring to participants in the health plan which will streamline access to care and pre-cert processes and to be on the lookout for new cards with new numbers on them as a result of that change, and that COVID rapid tests are available through express scripts to participants in the health plan.

- A. Motions for Presbytery from Commission on Ministry (COM)

- B. Actions taken by the Transitions Team (Convener Madelynne Lindsey)
  - Central Presbyterian, Elmwood Presbyterian and Elmwood West voted to merge.
     The Central building was offered for sale and a buyer was secured. This was ratified by the Presbytery of Newark. Subsequently and Administrative Commission determined that the model was not sustainable. There is a lawsuit pending.
  - 2. **Bethany Bloomfield** They are looking for a part-time interim. The team is encouraging the committee to search for a full-time interim since they intend to hire a full-time pastor.
  - 5. Rahway Rev. Erin Hayes-Cook dissolved her relationship with Rahway PC and has accepted a calling at Hackettstown PC.
  - 6. **Mountainside** An AC is in place. They are working to elect a PNC.
- **7. Wallington** An interim is needed. CRE Betty Fetzer is Moderating Session. COM Liaison is working with the congregation on next steps re: Leadership
  - **8. Taiwanese Congregation** Seeking an interim.
  - 9. Connecticut Farms Rev. Roberta Arrowsmith Honorably Retired January 31, 2022
  - 10. St. Paul's.- The relationship with Pastor Gomes was APPROVED for a six-month extension.

- **15. West New York Iglesia Presbiteriana Methodista** The Methodist are leaving this relationship. Jeremy Campbell spoke with the District Superintendent who is requesting that the remaining congregation pay the arrears for pension and utility bills.

- **18. Osceola** Liaison met with the session regarding a mission statement. Members of the Commission will meet with session.

2. The team **APPROVED** the Terms of Call for Rev. Diane Curtis effective salary of \$67,712 as sufficient (rather than \$69,900) because of the \$1,200 in line F representing an employer contribution to Diane's 403b. However, the vacation should read 4 weeks + 2 days including 5 Sundays. The Professional Reimbursement should be \$3,000 and the Continuing Education \$1,800.

# D. Actions taken by the Administration Team (Convener Rev. Mike Capron)

- 1. Maintain Pulpit Supply List The team decided that Ministers of word and Sacrament, as well as persons who have served as Commissioned Pastors may be added without further check. For other Ruling Elders, they will ask their pastor and also for some other secondary reference before adding them. The Team agreed that Mike Capron could handle the process and there was no need to vote on individual names.
- 2. Interface with Commissioned Pastors The team met with CPM and Rev. Victor Aloyo to discuss the work he has done with other presbyteries and bring a written description of how he is willing to lead a group to help our presbytery train and serve Commissioned Pastors.
- 3. The team discussed that some of the challenges faced by Commissioned Pastors are financial, especially in the realm of health insurance. Student debt can also be a problem. The Board of Pensions is helpful at answering questions in both English and Spanish.
- 4. the Team recommends that it would be helpful to remind people in the Presbytery about the Board of Pensions more often than every other year at a presbytery meeting.
- 5. **Boundary Training** The team is looking into some alternative plans for individuals who were not able to attend the last Boundary Training.

There will eventually be a need to do background checks on all members of the new presbytery for our insurance and to redo them every 3 years going forward.

Jeremy Campbell and Madelynne Lindsey have been meeting with liaisons to talk about all the information they have gathered from their assigned congregations.

# Commission on Preparation Report - 2/15/22

The Commission met on Wednesday, January 25, 2022. The agenda included dialogue with Rev. Mike Capron, Rev. Shelley Gardner, from COM and Rev. Victor Aloyo around the topic of "Providing clearer training, boundaries and roles for CRE/CLP". We set up a schedule for meetings (annual consultations) with persons under care over the next few months.

# **Grants Review Commission**

The Grants Team has begun to meet concurrently with the Community Ministries Team. Our Team will be developing an application form with criteria and guidelines for local congregations engaging in creative outreach. These grants will be similar to the Greystone Legacy and New Hope Grants in the former Elizabeth and the Service and Witness grants in the former Newark.

# **Community Ministry Commission**

The CMC currently consists of Valencia Norman, Dan Mitchell and Brooks Smith. We expect to add 2 members at this meeting.

We have conducted 2 joint meetings with the Grants Commission to introduce ourselves to one another and seek to clarify our responsibilities and resources.

Jerome Lane is the staff resource for both commissions. Working with Jerome we have agreed that the Grants Commission will focus on allocating funds to ongoing church programs and agencies in a way similar to the Service and Witness Committee of former Newark and the agency grants of the Mission Committee of former Elizabeth.

The CMC will allocate funds for shorter term projects and programs along the lines of the Greystone Grants of former Elizabeth and the New Hope grants of the Mission committee.

We agreed to create a single application form. We intend to present that form and an application process to the May presbytery meeting.

We have been informed that there is a fund of \$10069 available for disaster related expenses and \$8487 for Greystone projects. While the CMC understands that it is designated to serve as a disaster commission, we very much need someone with a passion for disaster response to serve with us.

Through the Community Ministry newsletter that Jerome has developed we expect to inform the Presbytery about the variety of church based ministries that serve our community.

# Rationale for Electing Volunteer Treasurer

When the PNENJ came into being it inherited three financial systems that included a contract with an accounting firm and three staff members with varying responsibilities for managing the flow and recording of financial transactions. Over the past year, a considerable amount of work has been done to consolidate our financial processes. That work was complicated by a number of factors, including the departure of two staff members.

Immediate steps were taken to fill the bookkeepers positions while the Office Admin position was filled with a temporary person. This enabled the presbytery to move forward while also giving some time to consider other staffing models. After a healthy conversation, the vision team adopted the recommendation of the personnel committee to move forward with a volunteer treasurer and to transition the bookkeeper into an expanded part-time position - Transitional Finance Coordinator.

This new position will also help us live into that part of the missional invitation that recommended the sharing of staff/resources between presbyteries. In this case, our current bookkeeper is also serving in the role of Financial Administrator for a neighboring presbytery.

Because of this new direction, our current treasurer was notified of the change, dismissed from the position, and is being provided with a severance package that recognizes his faithful service to the presbytery and the abundant work he did during the transition.

With the paid treasure's position eliminated, the presbytery must now elect a new volunteer treasurer.

# **Presbytery Treasurer**

Volunteer position for a Ruling Elder or Teaching Elder nominated by Vision Team and elected by the Presbytery

**Purpose**: Serve as the Treasurer of the Presbytery's Corporation; approves and signs checks for all disbursements.

**Accountability:** The Treasurer is accountable to the Presbytery through the Vision Team.

# **Responsibilities:**

- Serve as ex-officio member of the Finance Task Force
- Reviews and approves payable invoices prepared by the bookkeeper, and signs associated disbursement checks; review payroll taxes and withholding deposits
- Oversees the work of the bookkeeper, and ensures that clear concise reports
  of the presbytery's finances are provided to the vision team monthly and to
  the presbytery at each stated meeting.
- Supports the budget development process as needed.

**Term:** The Treasurer is elected for a term of three years and is eligible for reelection.

#### Recommendation

The Presbytery of Northeast New Jersey respectfully overtures the 225th General Assembly (2022) to direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

Shall F-1.0302 (c) be amended by inserting the following words [Text to be added is shown in bold.]: "Because the church is catholic, it strives everywhere to testify to Christ's embrace of men, women, and children of all times, places, races, nations, ages, **abilities**, conditions, and stations in life."

and F-1.0404 be amended by inserting the following words [Text to be added is shown in bold]: "a new openness in its own membership, becoming in fact as well as in faith a community of women and men of all ages, races, ethnicities, **abilities**, and worldly conditions, made one in Christ by the power of the Spirit, as a visible sign of the new humanity."

Further, the Presbytery of Northeast NJ recommends that disability be included in future lists of marginalized people in policy, procedure, and liturgy.

#### Rationale

The current foundational statement (F-1.0403) already uses language inclusive of people with disabilities. This amendment seeks to use consistent language around disability throughout the Foundational statements of the book of order.

"Well Chosen Words" (2010) states using inclusive and expansive language is one way to acknowledge and celebrate all people and bring recognition and a sense of belonging to people who have been historically marginalized in society and even in the church." This amendment would reflect this overture by making all parts of the Book of Order consistent in their inclusion of people with disabilities.

People with disabilities include 26% of the US population (CDC, 2020) making it the largest minority group in America. People with disabilities represent an important part of our church and they should be named in lists of people to be included.

Research shows a significant gap in presence and full participation for people with disabilities into the life of the church (Ault, Collins and Carter, 2013). The inclusion of people with disabilities in our polity shows our intention to be inclusive of this group.

We identify as being "people of the word," marking both our commitment to Biblical scholarship and exegesis and the importance of the words that we use when preaching, teaching, and guiding our church's polity. These small corrections reflect the value and importance that we put on the use of consistent inclusive language throughout our policies.
