# MINUTES.

#### Call to Order.

In accordance with the bylaws and electronic meeting policy of the Presbytery of Northeast New Jersey, the properly called Special Meeting of the Presbytery of Northeast New Jersey was called to order on Thursday, August 3, 2023, using ZOOM technology. The meeting was called to order at 7:08 PM (EDT), by the **Co-Moderator Reverend Dan Martian** (Livingston) and **opened with prayer.** SHe reminded presbyters that the meeting had been called to adopt the warrant for an Administrative Commission to serve the True Light (Paramus) congregation and that no other business was proper to this meeting.

A quorum was present.

#### Warrant.

Reverend Jeremy Campbell (Organizing Co-leader and Stated Clerk) presented the **warrant** (see appendix II) which had been recommended to the presbytery by **COM**. He explained the history for presbytery co-leader Steve Huston's work with the session and pastors and provided background on the ongoing conflict there.

Presbyters asked questions about scope of the warrant, including the possibility of the AC taking original jurisdiction of the session. It was shared that the AC will need to take jurisdiction for personnel, finance and discipline right away. It was also noted that membership on the AC will be by appointment of the COM chair in coordination with the stated clerk.

Rev Campbell then Moved the adoption of the Warrant on behalf of COM. Coming from a commission it needed no second and it VOTED to adopt it as presented.

#### Adjourn.

The docket having reached its end, it was moved seconded and **VOTED** to adjourn. The meeting was closed with prayer by Rev. Martian.

### Warrant

for an
Administrative Commission
of The Presbytery Of Northeast New Jersey
concerning
the True Light Church
Paramus, NJ

July 6, 2023

The Presbytery is given authority, in our polity, to:

**Nurture the covenant community of Christ...** promoting the peace and harmony of the congregations, and inquiring into sources of congregational discord; supporting congregations in developing the graces of generosity, stewardship, and service; assisting congregations in developing mission and participating in the mission of the whole church;... warning and bearing witness against error in doctrine and immortality in practice within its bounds; and serving in judicial matters in accordance with the rules of discipline (G-3.0303d.)

In exercising this authority, the Commission on Ministry has made a deliberate inquiry into the situation and conflict at the True Light Church, in Paramus. This inquiry consisted of sending Presbytery staff to meetings of the session, attendance at worship, leading of seminars. conducting of surveys, and conferring with the pastors and the Clerk of Session. In addition the COM and other representatives of the presbytery have received various communications, written and/or informal, from members of the True Light Church, in Paramus, and others who have observed the situation there.

In our connectional polity we are well suited to provide support for one another in times of trouble. We often form response or support teams to help in various situations. In order for a response or support team to be able to act on behalf of the presbytery and with the presbytery's full authority it requires technical language of a warrant for an Administrative Commission. The warrant describes the ways in which the commission will support, protect, and encourage the True Light Church in Paramus's "Ministry under the Word." COM, and the Presbyteries Co-Leaders remain committed to the long term viability and growth of this congregation and find this means of official support to be the best suited to ensure the strongest future of this ministry. While the Church is currently experiencing difficulties, we have great hope for its future life and ministry and have been encouraged by the commitment to ministry we have seen during our visits.

Therefore, the Commission on Ministry meeting electronically, has determined, that significant disorder is reported to exist in the True Light Church, in Paramus such that its ministry under the Word is placed in jeopardy. The Commission on Ministry requests the Presbytery of Northeast

New Jersey, at its Special Called Meeting, on August #, 2023, to create and empower an Administrative Commission.

Among the responsibilities given to an Administrative Commission in our polity are the following:

visiting particular councils, congregations or agencies over which they have immediate jurisdiction reported to be affected with disorder, and to inquire into and settle the difficulties therein, except that no commission shall have the power to dissolve a pastoral relationship unless such power has been specifically delegated to it by the appointing body. (G-3.0109b(5))

The Administrative Commission will have the following powers and responsibilities:

- 1. To visit the True Light Church, in Paramus.
- 2. To inquire into the difficulties occurring in the True Light Church, affording to all persons in interest fair notice and an opportunity to be heard on the matters at issue, in accordance with G-3.0109b.
  - a. The Administrative Commission shall have access to all records and documents which pertain to the life and mission of the True Light Presbyterian Church, without limitation. This shall include access to all financial documents and accounts as well as all personnel records.
  - b. The Administrative Commission shall seek to hear from all concerned parties, including members, former members, former pastors, families of members, friends of the church, visitors, the pastors and their families, current and former employees and staff people, building users, neighbors, and community figures. The Commission shall use its discretion in ensuring that all concerned parties have all pertinent documents communicated to them. The Commission shall conduct its business in the open, without undue secrecy. At the same time, the Commission shall take seriously any evidence or allegations of wrongdoing in the life of this church by any party or parties.
- 3. To settle whatever difficulties may be discovered, acting on behalf of the presbytery, which is "responsible for the mission and government of the church throughout its geographical district." In carrying out this responsibility, the Administrative Commission, acting on behalf of presbytery, is hereby empowered:
  - a. To provide coordination and guidance for the True Light Church, assisting the church in mobilizing its strength for making the most effective witness to Jesus Christ. (G-3.0303a) This will include at a minimum helping the session develop and implement appropriate staffing policies, job descriptions and review procedures. It will also include helping the session examine the budget and

helping to implementing appropriate financial procedures and controls if those in place are found to be lacking. It must include a full financial review or Audit of the church's finances. It will also include helping the session to plan in the short and longer term for sustainable pastoral leadership and programming staffing models for the congregation. Any other such guidance and coordination as becomes necessary during the course of the Commissions work shall be included in the scope of this warrant.

- b. To determine whether there are constituencies in the True Light Church which are unrepresented on Session and to counsel with the church if necessary.
- c. To "take appropriate action to correct any irregularity or delinquency it may discover." (G-3.0303d(3))
- d. To provide pastoral care for True Light Presbyterian Church in a time of crisis, conflict, and uncertainty. This shall include praying with and for the congregation, Session, Pastors, and their families; encouraging communication among the participants in the church's life; seeking opportunities to recommend services of confession, healing, and reconciliation; and directing all participants in the church's life to a renewed encounter with the demands of God's Word.
- e. To immediately assume original jurisdiction of the session for matters of finance, personnel and discipline.
- f. To order if it determines, after a thorough investigation, and after full opportunity to be heard has been accorded to the session, that the session is unable or unwilling to manage wisely the affairs of its church, that the presbytery assume original jurisdiction over True Light Church.
- g. To order if it determines, after a thorough investigation, and after full opportunity to be heard has been accorded to the pastors, that the pastoral relationship between the True Light Church and Revs. Joo Whang and Yongmin Lee be dissolved. In the event that the pastoral relationships are dissolved, the AC may negotiate such severance packages as they deem appropriate which shall be paid by True Light Presbyterian Church.
- h. To order if it determines, whatever processes of mediation, reconciliation and leadership education and development, it deems necessary for pastors, elders and potential leaders in order that healthy patterns of relationships amongst the leaders and congregations may be reestablished.
- i. To bring a recommendation to a regular or special meeting of the presbytery, if they see fit, with regards to declaring schism, splitting the church into two

churches, or dissolving the church all together. Any such recommendation will be non amendable as a result of its complex and contextual nature.

The Commission shall be empowered to perform all administrative and other tasks necessary to fulfill its charge and to carry out the responsibilities delegated to it.

This Administrative Commission shall assist the Session of the True Light Church in the fulfillment of its responsibilities listed in G-3.0201. The presbytery respectfully requests the Moderator of the Session of the True Light Church assist the Administrative Commission by inviting those recommended by the Commission to moderate the session in his stead.

This Administrative Commission shall report to presbytery in May 2024, when it will cease to function unless its mandate is specifically extended by the presbytery at that time. The presbytery may choose to extend the mandate of this Administrative Commission in six month increments, with the Commission reporting to presbytery at the close of each such period.

Membership in this Administrative Commission shall be by appointment of the Moderator of the Commission on Ministry, in consultation with the presbytery Co-Leaders.

If requested by the Administrative Commission, Northeast Presbytery shall secure Counsel for their work.

뉴저지 참빛교회에 대한 뉴저지북동노회 목회행정위원회 위임서

뉴저지 북동노회는 미국장로교 헌법에 준하여 다음과 같은 권한을 부여 받습니다:

그리스도의 언약 공동체를 육성하고... 교회들의 평화와 화합을 촉진하며, 교회들 간의 갈등 원인을 조사하고 규명합니다. 그리스도의 몸된 교회들이 서로 관용하며, 경영 및 봉사의 덕을 발전시키는 데 지원하며, 교회들이 복음적 미션을 개발하고 전체 총회적 차원에서의 미션에 참여할 수 있도록 돕습니다. 이러한 사역을 실행하는 범위 내에서 교리적 오류와 실천 과정에 있어 발생할 수 있는 불명예스러운 처사들에 대해 경고하고 증언합니다. 규율에 따라 사법적 문제들에 대해 서비스를 제공합니다 (G-3.0303d.).

장로교단의 이러한 연결적 행정체제는 어려운 시기에 있는 교회들에게 지원을 제공하기에 적합한 환경을 갖추고 있습니다. 우리는 여러가지 다양한 상황에서 도움을 주기 위해해결책을 위한 지원팀을 구성합니다. 목회행정위원회가 장로교 노회를 대신하여 그리고 장로교 총회의 전체적 헌법적 그리고 행정적 권한을 가지고 대처할 수 있도록 하기 위해서는 행정위원회 위임장이 필요합니다. 이 위임장은 목회행정위원회가 파라머스의 참빛교회의 "말씀 안에서의 사역"을 어떻게 잘 지원하고, 교회이 화평과 영적건강을 보호, 격려할 것인지를 설명합니다. 목회행정위원회(COM)와 노회 리더들은 본 참빛교회의 장기적인 생존과 성장에 헌신하고, 이러한 목회사역의 더욱 밝은 미래를 가장 견고하게 보장하기위해 목회행정위원회의 개입과 지원이 절실하다고 느끼고 있습니다. 현재 참빛교회가 어려움을 겪고 있지만, 우리는 그 미래적인 생명과 사역에 큰 희망을 품고 있으며, 노회 리더들의 방문 중에 참빛교회가 보여준 복음사역에 대한 헌신에 격려받았습니다.

따라서, 목회행정위원회는 신중하게 회의한 결과, 파라머스의 참빛교회에서 이루어지는 목회적 사역들이 성경말씀의 인도하심을 따르지 못하는 위태로운 부조화가 교회의 영적 아픔과 건강에 상당하게 영향력을 미치고 있다고 판단하였습니다. 목회행정위원회는 2023년 8월 #일에 예정된 뉴저지 북동노회의 특별 노회를 통하여 행정위원회를 구성하고 참빛교회의 목회와 행정적 권한을 위임을 위해 요청할 것입니다. 목회행정위원회에 주어 진 책임과 권한의 일부는 장로교 헌법이 아래와 같이 규명합니다.

해당 행정위원회가 직접 관할하고 있는 특정한 협의회, 교회 또는 기관들을 방문하여 부조화가 발생한 것으로 보고되고 있는 사항을 조사하고 해결합니다. 다만, 임명된 노회기관에서 명시적으로 위임 받지 않은 한, 어떤 행정위원회도 목회 관계를 해소할 권한을 가지지 않습니다. (G-3.0109b(5))

목회행정위원회는 다음과 같은 권한과 책임을 가집니다:

- 1. 파라머스에 위치한 참빛교회를 방문할 수 있습니다.
- 2. 참빛교회에서 발생하는 어려움들을 조사하며, 이와 관련된 관심을 가진 모든 이해관계 자들에게 G-3.0109b에 따라 공정한 공지와 이의를 제기할 수 있는 기회를 제공합니다.

- a. 목회행정위원회는 제한 없이 파라머스의 참빛교회의 교회생활과 사역에 관련된 모든 기록과 문서등을 살펴볼 수 있습니다. 이는 교회 재정문서와 회계부터 모든 인 사 기록에 이르기까지 모든 자료들을 포함합니다.
- b. 행정위원회는 참빛교회의 모든 구성원, 전직 구성원을 포함한, 전직 사역목사, 구성원 가족, 교회의 친구, 방문객, 목사들과 가족, 현직 및 전직 직원들, 건물 사용자, 이웃, 지역 사회 인물 등 모든 관련 당사자들의 의견을 면밀하게 듣고자 합니다. 이과정시 모든 관련 당사자들에게 관련 문서를 제공할 것이며, 목회행정위원회는 비밀스러운 행위 없이 열린 방식으로 이 모든 업무를 진행할 것입니다. 동시에 목회행정위원회는 교회 생활에서 어떤 당사자로부터든지 불법행위에 대한 모든 증거 또는 주장을 신중하게 이 과정중 고려할 것입니다.
- 3. 현 목회와 교회생활에 감지되는 어떤 어려움이든 해결하기 위해,지리적 지역 내 지교회의 사역과 행정에 책임을 지는 노회를 대신하여 목회행정을 진행하며,이 책임을 이행하기위해 목회행정위원회는 북동노회를 대신하여 다음과 같이 권한을 부여받습니다:
  - a. 참빛교회에 대해 목회조정과 사역을 인도하여, 예수 그리스도에 대한 증거를 보다 효과적으로 시행할 수 있도록 돕습니다. (G-3.0303a) 이는 최소한 당회에게 복음이 제시하는 합당한 직원 고용 정책, 직무 기술서, 그리고 검토 절차를 개발하고 진실되게 시행하는데 도움을 주는 것을 포함합니다. 또한 당회의 예산 검토와, 필요한경우 적절한 재정 절차와 통제 방안을 시행하는데도 도움을 줄 것입니다. 교회 재정에 대한 전체적인 검토 또는 감사도 포함됩니다. 또한 교회의 장기적이고 지속 가능한 목회 리더십과 교회 제직들과 구성원들을 위한 프로그래밍 직원 모델에 대한 계획도 돕는 것입니다. 목회행정위원회가 참빛교회를 돕는 과정중 필요한 다른 안내와 목회조정 사항들도 위임장의 범위에 포함됩니다.
  - b. 참빛교회 당회 구성에서 공정하게 모든 그룹을 공정하게 대표되지 않는 당회원들이 있는지 판단하고 필요한 경우 교회와 이에 대하여 상담할 것입니다.
  - c. 발견된 어떤 불규칙성 또는 불법행위에 대해 적절한 조치를 취하기 위해 노력합 니다. (G-3.0303d(3))
  - d. 위기와 갈등 및 불확실한 상황에서 참빛교회에 대한 목회적 관심과 보살핌을 제 공합니다. 이는 교회 구성원, 당회, 시무목사 및 그 가족들을 포함하여 함께 기도하 는 것을 의미합니다. 또한 교회 교우들 간의 건강한 소통을 촉진하고, 회개, 치유, 화 회를 위해 예배를 권장하는 기회를 찾아주며, 교회 교우들에게 회복을 위하여 하나 님의 말씀과의 새로운 만남을 인도하는 것을 지시합니다.
  - e. 재정, 인사 및 교회내 질서 문제에 대해 당회의 본래 사법 행정권을 즉시 행사합니다.

f. 목회행정위원회가 모든 조사를 면밀하게 진행한 후, 그리고 당회에게 충분한 청취 기회를 부여한 후에도 만일 당회가 교회의 사안을 현명하게 처리하지 못할 경우, 노회에서 파송된 목회행정위원회가 본래의 참빛교회 당회권한을 위임 받습니다.

g. 목회행정위원회가 모든 조사를 진행한 후 시무목사들에게 충분한 청취 기회를 부여한 후, 참빛교회와 목사들 (황주 담임목사, 이영민 부목사)간의 목회 관계를 해 소하기로 결정할 경우, 그 목회 관계를 해소합니다. 만약 목회 관계가 해소되는 경 우, 목회행정위원회는 적절하다고 여기는 목회해소 퇴직금을 협상할 수 있으며, 이 퇴직금은 참빛교회가 지불해야 합니다.

h. 목사, 장로 및 교회리더들 간의 건강한 관계의 재창출을 위하여 필요한 중재와 화해 및 리더십 교육 및 개발 과정을 결정합니다.

i. 만약 꼭 필요하다고 여겨질 경우, 노회의 정규 또는 특별 노회를 개최함으로 참빛 교회 내 다툼, 참빛교회를 두 교회로 분할하거나 또는 참빛교회를 완전히 해산하는 것과 관련하여 권고안을 노회에 상정할 것입니다. 이러한 권고안은 성격상 매우 복잡하고 문맥적으로 상황적인 표현들이 기록되므로인해 수정이 불가능합니다.

목회행정위원회는 교회 회복을 위한 권한과 책임을 이행하고 위임받은 책임을 수행하는데 필요한 모든 행정적 및 기타 작업을 수행하기 위한 권한이 있습니다.

행정위원회는 참빛교회의 당회를 G-3.0201에 명시된 책임등을 이행하는 것을 지원합니다. 노회는 당회의 의장을 행정위원회가 추천한 당회장을 초대하여 당회를 대신 주재하고 인도하기를 정중하게 요청합니다.

목회행정위원회는 2024년 5월에 노회에 보고하며, 그 시일까지 노회에 의해 명시적으로 연장되지 않는 한 위임된 책임과 기능을 멈출 것입니다. 장로회는 이 목회행정위원회의 책 임을 6개월 단위로 연장할 수 있으며, 해당 기간마다 목회행정위원회는 노회에 보고하게 됩니다.

목회행정위원회의 구성원은 교회사역위원회 위원장과 장로회 공동 리더들과의 협의를 통해 임명됩니다.

목회행정위원회의 요청에 따라, 뉴저지 동북노회는 그들의 업무를 수행하기 위해 변호사를 선임할 수 있습니다.
