MINUTES.

Call to Order.

In accordance with the bylaws and electronic meeting policy of the Presbytery of Northeast New Jersey, the 11th Stated Meeting of the Presbytery of Northeast New Jersey was called to order on Saturday, September 16, 2023. It was a Hybrid meeting, both in person in the sanctuary at First Ridgewood and using ZOOM technology. The meeting was called to order at 9:39 am (EDT), by the Co-Moderator Rev. Dan Martian (Livingston) and opened with prayer. The meeting docket was arranged in a worshipful work format in which the elements of worship are interspersed with the business of the body.

A quorum was present.

Rev. Bruce Ballantine, host pastor welcomed presbyters and oriented them to comfort facilities.

Rev. Martian led the presbytery in a call to worship and opened the meeting with prayer.

Stated Clerk.

Teaching Elder Jeremy T. Campbell (Stated Clerk), presented the report of the Stated Clerk. He presented the Consent Agenda.

The Presbytery **VOTED** to enact the items on the Consent Agenda.

Living our Mission — through our finances.

Finance Team.

Elder Rick Friedl presented the report of the **finance committee**. He shared information about the **work which they have done so far**. Their written report can be found here. He recommended on behalf of the team, and the presbytery **VOTED** that the **Per Capita Rate for 2023 be reduced to \$38 per member**, noting that because of over head savings and better use of some of the various funds that the presbytery could increase its mission spending even with this reduction.

COM report.

Rev. Bobbie Arrowsmith presented part 1 of the report of the COM. She shared the commissions recommendation of a **3% increase to the minimum terms** of call, and **recommendation that all pastoral salaries be increased at least 3% in 2024**. It was **VOTED** to enact this recommendation. She shared that COM will be back with **other edits to the minimum terms of call** necessitated by GA's decision to require 12 weeks of "Family Medical Leave" **in November** but wanted to present the salary increase now so that congregations can budget.

Rev. Martian led the presbytery in a prayer of confession and the gloria patri was sung.

Living our Mission — In our Communities and World.

International Peacemaker Gaia Magdalena Luczak shared about her work with refugees in Poland. Refugees from Ukraine along the Polish border with Russia are being treated poorly. There is great needs and few resources. She shared compelling first person stories and encouraged people to both raise awareness of the ongoing refugee crisis and to get involved if possible in supporting those working with refugees.

Living our Mission — Hearing God's word.

Following a sermon# by mission coworker Rev. Elmarie Parker Elder Jerome Lane, Jr. shared with presbyters about how the former church Wolff Memorial has been transformed into a community ministry center with many partners engaged in ministries there. He also shared about grants awarded by the Grants Commission and Community Ministries commission.

Living our Mission: Giving.

A presbytery **worship offering** was collected to support **the international peacemaker and Rev. Parker**.

The Lord"s Supper

The Co-Moderators of the presbytery **Rev. Martian and Pastor Peterson** presided at the celebration of the **Lprd's Supper**.

COM report (Part 2).

Rev. Bobbie Arrowsmith presented part 2 of the report of the COM. The recognized recent pastoral transitions welcoming new pastors to the presbytery and congratulating those in new positions.

Nominating Committee.

Rev. Dr. Deborah Huggins (Summit, Central) presented the Nominating report (see appendix XII)

She placed the slate in nomination. Nominations from the floor were filled into vacant slots. it was **VOTED** to elect the slate including the nominees from the floor. All elected persons are listed in the slate in the appendix which follows.

Adjourn.

The docket having reached its end, and the moderators hearing no new business, the Presbytery **VOTED** to adjourn following the small groups, and the meeting was closed with prayer and benediction offered by Pastor Doris Peterson (Co-Moderator).

Report of the Finance Committee September 14th 2023

From our meeting is May, we brought forth 5 key actions and activities we were working on to better the position the Presbytery for the short and long term. Below are the 5 actions we presented and their status, as well as one proposal for your vote:

- 1. Position our investments with the Presbyterian Foundation and Asset Capital Managers to generate annual revenue / income to support the activities of the Presbytery while growing our overall equity positions. To date, we have met with both the Foundation and ACM to review our strategy and positions. Though the Presbyterian Foundation is a closed looped system (I.e. they take no input from us nor do we have a chance to remove our funds), we are earning 4.5% in 2023 and will earn 4% in 2024. From the ACM side, we have set up the "sidecar" within our portfolio where dividends paid from our investments are deposited and earning current money market rates (5.25% to 5.5%). This money will support the budget without reducing our investment portfolio.
- 2. The full audit of the 2021 fiscal year is still ongoing. Though we anticipated this being completed by our Sept meeting, there is still a page of items that we need to provide to the audit team for them to complete the audit. As we continue to try to find information from the our formation, we are confident this will be completed in 2023. With a prayer and elbow grease, maybe by the November Presbytery meeting.
- 3. We have been active with the committees in getting input for the 2024 Budget. Liaisons were appointing from our team to each committee. We feel with your help and the input received, we are moving quickly to finalize our 2024 budget. Our goal is to have to budget out to the members by the second half of October for a review. We will then schedule a Q&A ZOOM meeting to receive input, with everything ready for a formal vote during our November Presbytery Meeting.

- 4. We meet the 3rd Wednesday of each month to review the monthly numbers, discuss ongoing issues and continue to learning from each other how to manage all the moving parts of this 3 in 1 Presbytery. We are blessed with tremendous talent and knowledge making this Committee a true joy to be a part of. Our numbers are solid though August and we are on budget without having to draw a single dollar out of our portfolio to support this year's expenses. If we do need to withdraw any money, it will come from the sidecar with no impact to our investment positions.
- 5. Lastly, we do communicate regularly with our leadership team. We enjoy a "2-way" street with both Steve and Jeremy where we get input from them and they ask for input from us. We promised to be transparent and communicative. We believe the relationship is excellent and appreciate everyone's support.

We do need to bring one **motion** from the CA&F Committee to this body for a vote. Because of the change in our Facility budget and making use of investment gains in our restricted accounts funds toward Grants, CMC, COM and Prep on Ministry, we are proposing to **reduce 2024 Per-Capita to \$38** vs the expiring \$40. This reduction will not impact our budget, but actual allow us to increase total mission spending. Your support for this reduction is appreciated.

Vision Team met for its regular meeting on zoom at 4:00 PM on June 27th 2023.

As this was the first meeting of the Vision Team after the switchover for terms introductions of those present were facilitated.

The team spent time debriefing the hybrid presbytery meeting. The small groups were appreciated. It was felt that the technology went very well. Jerome, Trudi and Somerset Media were thanked for their contributions to that. The hospitality of the host church was also lifted up as excellent. The largest complaint was that voting was a little slow in order to account for those online but it was understood that that comes with the territory. It was agreed that we would continue with a Hybrid meeting in September, and then have November and February online.

Steve then shared about an appreciative inquiry guide which could potentially help us accomplish our visioning process. The goal is to get as much feedback from as many people as possible. People liked the idea, but expressed concerned about the length. There were questions about the difference between interviews and surveys. There was also discussion of engaging the languages we worship in regularly. Hearing from diverse voices is an important value to us. He asked for additional feedback by 7/15.

Gayle Griffin shared about the personnel process that the Admin Operations Team is working on. They are working to roll out a comprehensive review process as well as consideration of future staffing needs.

Jeremy explained that there would likely need to be a special meeting over the summer to create an AC to serve True Light church in Paramus. It was agreed that could be approved by email when the time comes.

Vision Team met for its regular meeting on zoom at 4:30 PM on August 22nd 2023.

First addressed were some procedural issues. Acting in their capacity as the trustees of the corporation the Vision team **VOTED** to approve the sale of the former Central Presbyterian Church Newark according to the revised terms of sale, following the latest round of litigation. It is expected that the closing will take place on or about September 1st. While the original sale price was to be \$400,000 the final sales proceeds will now be \$537,500.

A request from Elizabethport Presbyterian Center that the presbytery approve refinance of an existing loan through Pilp was introduced. The current loan through a commercial bank requires Eport to annually reapply including an annual commercial appraisal of the property at their expense and is at a higher than market rate. They have been making timely payments on the loan since its inception about 15 years ago and have paid down the approximately 4 Million load to a current balance of about 2.6 million. Since they are a subsidiary of the presbytery they qualify for a fixed rate loan through PILP. It **VOTED** to approve their loan application.

The bulk of the discussion was around the end of the lease of the current office. Our lease expires at the end of April 2024, and we must give notice to the landlord by the end of October as to our intent to renew or not. Given the high cost of the office, and the relatively infrequent use by anyone other than staff it was recommended by the task group thinking about this, and then **VOTED** by the vision team **not to renew.** There was some discussion of what to do instead, acknowledging that there needs to be a place to receive mail and to store some required files, as well as places for the staff to work, and for meetings to take place. The idea of distributed staff across a few locations in smaller offices, preferably in a church where any rent paid would help go to ministry and mission, had a lot of support. The team working on this will continue to explore possibilities but it was agreed we are moving out of the current space.

Appendix III

Rev. Steve Huston introduced the interview guide which will provide input for the discernment process. This process is based on an appreciative inquiry model. Given the lateness of the hour it was agreed that interviews would be completed in pairs with the feedback and information provided by the end of the month. Once the vision team completes their interviews the same process can be used to gather information from others.

Rev Steve Huston closed with prayer at 5:16.

Approved: **R**ecommendation that the presbytery raises the minimum compensation for pastors, effective salary, 3% for 2024. Rational: Consumer Price Index currently 3.2% and Cost of Living Calculation (COLA) is expected to be announced in October at 3%.

September 2023 Co-Leader Report

I imagined things around the presbytery might slow down during the summer while church programs were taking a break, pastor's were vacationing, and church committees didn't meet. That was not the reality. The time since our last stated meeting has been filled responding to numerous phone calls and emails. Most issues could be resolved quickly, "What's the password for posting a position on www.mynextcallpcusa.org?" (the answer is callfinder2022). Other questions were more complicated and involved research and conversations with representatives from places like the Board of Pensions and the Presbyterian Foundation. Some issues had to be resolved in person (like the sprinkler inspection for an unoccupied church in Bayonne) and so I spent a good deal of my time this summer on the road visiting with sessions, church committees, and pastors. I also got to do some pulpit supply, a couple of last minute fill-ins for a baptism and communion, and attend some congregational celebrations.

When I wasn't on the road resourcing pastors and congregations or responding to calls and emails I was busy with the continued organizational work of the Presbytery. The Administrative Operations Committee was unboarded in June and has begun the necessary work to make sure the Presbytery's policies are in compliance with changes to the Book of Order that took effect this summer. They have also been working to evaluate the Presbytery's staff in order to make informed decisions about future staffing needs, staffing models, and compensation.

Finallyh, I have been working with presbytery leaders and clerks from around the presbytery and the synod to discuss and create sample policies for mid-councils and congregations in regards to anti-racism, anti-harassment, and boundary training. In addition to these specific policies I have been working on a "Policy on Policies" for the PNENJ that reflects the aspirations expressed in the missional invitation.

To that end, I am also currently reading Many Voices, One Song by Jerry Koch-Gonzalez and Ted Rau. The book explores the topic of Sociocracy, a system of self-governance that distributes power throughout an organization in order to create decision making that works for everyone. The more I read, the more I see our own polity following many of the principles outlined in the book. Yet, there are still areas where our polity prevents all voices from being heard and listened to, especially those who have historically been silenced by the "rules".
